Enclosed are the applications for sanctioning your 2010 Oregon ASA Invitational Tournaments.

Please review the sanctioning terms and requirements prior to submitting you application.  
**These terms and requirements are a prerequisite to approval.**

Applications will be reviewed and will only be approved after the application and a check for the sanction fee is received by the State Office.

Applications that are not complete or legible **will be returned** and risk not having their event(s) listed or sanctioned. One application is needed for each date and classification you are requesting. Indicate division and classification you are offering.

Brackets are based on Age & Classification. If you have a 14U Open it is one bracket. If you have a 14A Division and a 14B Division it is two brackets. Fees are charged per bracket (See fee schedule). The information on your application is how we will list your tournament.

Listings. The following is a sample of how tournaments will be listed on line with explanations. (See detail for classification listings)

Girl's Fast Pitch 14A	14A and below are welcome	1 set of trophies
Girl's Fast Pitch 14 Open	14A & B are combined	1 set of trophies
Coed Slow Pitch	Recreational play	1 set of trophies

Tournaments are considered for sanctioning based on team registration and geography. Priority will be given to those tournament directors with excellent performance records and those that filed a post tournament report on Register ASA (VTD) in 2007.

Applicants could be asked to change date, age, or classification to eliminate weekend overload. Refund of application fees will be sent to applicants that are not approved. **Refunds will not be provided for any other reason(s).**

Tournament directors must abide by all ASA rules and regulations. **Tournaments that conflict with championship play cannot be sanctioned per ASA code.**

**Once you have completed your application, signed and dated your agreement, and mailed your application, agreement and check, please go to register ASA ([www.fastpitchsoftball.net](http://www.fastpitchsoftball.net)) and register your tournament. All tournaments must use the Register ASA website to be approved.**

**Invitational Tournament Sanctioning Agreement**

**Tournament Applicants**

Oregon ASA Softball takes great pride in our invitational tournaments, the teaming of quality tournament directors, trained ASA umpires and support and guidance of Oregon ASA has become the primary reason teams **“Play ASA.”**

Team managers have become great customers and are very cognizant of the benefits of ASA umpires, ASA rules, and the guarantee of registered, classified teams, thus keeping the field equitable and making winning possible.

Veteran Tournament Directors report their tournaments fill quickly and usually have a waiting list of teams, year after year. The ASA sanctioning of you as a director and your tournament reflects your pride and your commitment to Oregon ASA teams.

**Terms and Requirements**

**Only ASA Registered and Classified Teams** are eligible to participate.

All teams **MUST** provide a signed copy of their ASA roster or Register ASA Roster **PRIOR** to participation. Teams without will not be allowed to play.

**ASA Rules will govern all play**

Any exceptions **MUST** be approved and **PRINTED** on tournament rules and advertisements.

All teams **MUST** be given a copy of the tournament rules.

Common Exceptions would include increase home run limits, batting the roster, injury re-entry or allowable pickup players.

**Only Oregon ASA Registered Umpires** may officiate tournament games.

Non-registered umpires negates **sanctioning** and **insurance**.

ASA Umpires invited by Local or State UIC from outside of Oregon are eligible to officiate.

Contact your local ASA UIC with your tournament information to arrange assignments.

**Tournament Bracketing and Awards must be what you advertised.**

Managers must be informed in a timely manner of changes and have the option to withdraw.

Consolation games cannot be considered part of the guarantee.

Bracketing and advancement must be fair and equitable to all teams.

All awards must be given at the conclusion of the tournament.

**Tournament Reports**

Register ASA Order of Finish must be completed and online 72 hours after tournament.

Rained out or canceled events must be fair and equitable to all teams.

**Failure to report properly and by deadline may result in suspension of future events.**

**I have read the preceding rule and agree to abide by all rules as outlined. I understand that my failure to abide by these rules may result in the removal of my current tournament sanction and future sanctioning.**
